## Superintendent's Message

Dear Colleagues,

Passed by Congress in December of 2015, the Every Student Succeeds Act (ESSA) is a federal law that requires states to have a plan for spending federal funds, for measuring the skills students learn, and for supporting students in making academic progress. ESSA, which replaces the No Child Left Behind Act (NCLB), is largely focused on the needs of historically disadvantaged students, including students from low-income homes, students whose home language is not English, and students with disabilities. The law is not a federal plan; it is a federal law requiring states to develop plans of their own.

Over the past two months, Department staff and I have traveled the state, convening public meetings on ESSA and meeting individually with professional associations, civil rights advocates, business leaders, and institutions of higher learning. In those meetings, we have shared data on the profound successes achieved by Louisiana students and the profound challenges yet to be overcome. You can find a copy of the presentation detailing this information [here](#), and you can find recorded public discussions [here](#).

Later this week, the Department will release a report summarizing the organizations involved in the Louisiana ESSA discussion to date, the process undertaken so far, commonly shared thoughts and ideas, and the timeline for plan development. Largely based on this report, the Department will release later in the fall a draft framework for the state's plan. This draft will be intended primarily to elicit further and more specific feedback. As the fall and winter proceed, the Department will continue to refine and issue further draft plans, until final submission to the U.S. Department of Education in 2017. We estimate and hope that the process will take roughly one full year in total, allowing for educators and families to return to school next school year fully aware of the approved state plan. ## **2016-2017 Compass Action Steps and Tools**

The Compass tool supports teachers and principals in defining expectations for student learning and monitoring progress against those goals throughout the year. The following action steps and tools support the Compass process for the beginning of the 2016-2017 school year.

- **New Evaluator Training:** All new evaluators must complete a training to be certified to complete Compass evaluations. This requirement can be met by attending department-led trainings or those led by local education agencies. ## **[Flexibility Granted to Assist Child Nutrition Programs in Parishes Subject to a Major Disaster Declaration](#)**

USDA has granted some flexibility to assist participating Child Nutrition Programs in parishes subject to a Major Disaster Declaration pursuant to FEMA-4277-DR. USDA has allowed SFAs flexibility in the meal time and meal pattern (foods served) through **September 30, 2016**, and Schools in Disaster Declared Parishes to claim ALL meals served from the time they open after the flood through **September 30, 2016**, at the free reimbursement rate.

## McKinney-Vento Homeless Program

The McKinney-Vento Homeless Assistance Act is the primary piece of federal legislation dealing with the education of children and youth in homeless situations. Its key themes are school access and stability, support for educational success, and child-centered decision-making. In light of the recent natural disaster, LEAs need to take the actions below to comply with federal guidance and identify and provide services to students and families who are experiencing homelessness. Students qualify for homeless status if they are sharing housing with other persons, including doubled-up with family members, or are living in motels, hotels, trailer parks, or camping grounds due to the lack of adequate accommodations.

- Use and share the Homeless Hotline for inquiries and referrals - **Homeless Hotline: 844-533-4187**.
- Ensure parents or guardians complete the [Residency Questionnaire](#) for current students, whose residential status has changed, and newly-enrolled/displaced students to identify homeless children and youth.
- Complete the [Title X, Part C McKinney-Vento Referral Form](#) for eligible students and provide a copy to the LEA homeless liaison.
- Code students experiencing Homelessness due to recent floods in the Student information System (SIS) to code **02-Flooding**.
- Coordinate wrap-around services within the LEA, such as the National School Lunch Program.
- Coordinate and provide transportation services for displaced students to schools of origin, as applicable.
- Update Homeless Tracking System (HTS) to reflect services provided and support federal data reporting.

LEAs should remember to adhere to FERPA, Act 837, and Act 677 when sharing personally identifiable information to protect student privacy.

## Assessment & Accountability

### District Test Coordinator Reminders

This section provides LEAs with reminders and updates on information related to testing.

#### Training and Support

- **New DTC Training** will be held at the September Collaborative as a Supervisor session. All new District Test Coordinators should attend this training.

#### Accountability

- **DCAI and ACT Rosters:** LA Data Review is closed for new submissions to DCAI and ACT. The system remains open for communication and updates of previously-submitted requests. Districts should not submit requests for Carnegie credit updates. Official transcripts in STS must be updated **by September 9** in order to update Carnegie credits.
- **Assessment Rosters:** Data certification for Spring 2016 assessments is open and has been extended to **September 9**.
- **LEAP Subgroup with Subclaim Reports:** District and school subgroup with subclaims CSV file **will be available in DRC eDirect on Friday, September 9**. The file includes Spring 2016 LEAP ELA, math and science results for all students in grades 3 through 8, as well as targeted subgroups, by subclaim (ELA and math only). The data can be used by districts and schools as they plan to address subgroup performance gaps and develop targeted instructional strategies. The data are also useful for inclusion in grant submissions, development of programs and interventions,

and budgets.

## Data Sharing Agreement Update

### **New Agreements**
